Montcalm Area Intermediate School District Education Endowment



The Montcalm Area Intermediate School District (MAISD) has teamed up with the Central Montcalm Community Foundation to establish an endowed fund for Montcalm County Students. The MAISD Education

Endowment will provide scholarships to our students as they matriculate to post-secondary education and technical training.

These scholarship funds are for students who have an Individualized Education Program (IEP) and attend school in Montcalm County. As the fund grows, additional scholarships will be developed to assist students who attend programs operated by the MAISD. These may include those attending the Montcalm Area Career Center (The MACC) or those experiencing homeless episodes via the Homeless Student Supports program.

Dental Clinic Benefits from Foundation Grant

Sheridan Community Hospital (SCH) was the recipient this year of a significant contribution from Central Montcalm Community Foundation (CMCF) to establish its new hospital-based dental clinic. CMCF was the lead donor. Randolph Flechsig, SCH Administrator, believes "the generosity of CMCF is a much need component in the life of a rural community and essential to maintain a quality of life."

The hospital-based dentistry program is a collaborative partnership between Sheridan Community Hospital and Michigan Community Dental Clinics (MCDC). "The partnership with MCDC was key to making this service a reality, their vision and commitment was instrumental in the launching this new service at SCH", said Flechsig.

There are a significant number of young children and developmentally disabled children and adults who reside in Montcalm and Ionia Counties who are unable to receive dental care in a traditional dentist's office due to severe decay and special needs. These individuals and their families previously had to travel considerable distances, often as far as Ann Arbor or Muskegon, to receive hospital-based dental care. The new dental clinic now provides much needed local access to this care.



program is an important element for MCDC to increase its capacity to serve low-income, uninsured and newly insured people.

The relevancy of a rural community hospital like SCH is in no greater view than when it can offer local access to a program like the new dental clinic. The SCH board of trustees is committed to services that meet local needs. "It's about community enrichment first", said Jay Tans SCH board chairman, "and sustaining our local hospital requires community stewardship as demonstrated by the generosity of grant funding provided by CMCF."

Assisting in establishing scholarships and selecting recipients, will be former MAISD staff. This advisory board consists of Bill Seiter, Paula Fortino, Helen Hamler, Rosalee Hull, and Jackie Kemler. The MAISD Superintendent, Dr. Scott Koenigsknecht, will also participate in the process. The advisory team represents over 150 years of service to communities, schools and students throughout Montcalm County.

It is evident that a lack of access to dental care is linked with poor overall health outcomes and impaired functioning in areas such as learning ability, caregiving, employability and work attendance. But historically, Montcalm County has had poor access to oral health care. This new Today, small community hospitals must rely upon the generosity of grant funding and donations to advance new programming and for capital investments. But this is not new. When the U.S. first sought to proliferate the building of local hospitals, particular in rural areas, in enacted the Hill Burton Act, which gave hospitals grants and

loans for construction and modernization. In return, hospitals agreed to provide a reasonable volume of services to persons unable to pay and to make their services available to all persons residing in the facility's area. So, today as we look at ever increasing cuts in hospital payment, we must again look to outside funding – not debt - to enhance local access to needed medical services. "We are very fortunate CMCF is filling this role for our region", said Flechsig, "their mission serves an essential role in preserving our community hospital and local access to health care."

Sheridan Community Hospital, designated as a Critical Access Hospital (CAH), has 22 beds which

includes 10 licensed Swing Beds. The Hospital offers an array of clinical services including ambulatory surgery and 24 hour emergency department service. The Hospital also has a physician staffed 24/7 Walkin-Clinic located at the hospital. The Hospital offers access to primary care at its clinics in Sheridan, Stanton, and Edmore. It employees over 180 people. Sheridan Community Hospital is celebrating its 70th Anniversary in 2014, having served the greater Montcalm County region since 1944.

If you are unable to deduct the full amount in the current year because of percentage limits of adjusted gross income, the unused deduction can be forwarded for the next five years as charitable deductions. Outdoor Classroom is up and running!

The CMUE Outdoor Classroom is up and running thanks to a grant from CMCF and many volunteers! Last year we were awarded an \$800 grant from CMCF to build an outdoor classroom. Throughout the school year, 13-14, we planned and consulted with many volunteers to construct a beautiful classroom in the grove of trees behind CMUE. The list of volunteers includes: Patty and Craig Rockafellow, Rob and Joe Baldwin, Lynn, Karen, and Brent Wickerham, Brett Jensen at Big L in Sheridan, Jeremy and Faith Swan, Brennan, Shannon, Riley, and McKenna Bowen, Tim Bohen, Patrick and Susan Hill, Mike and Susan Koster, Jim and Barb Warshchefsky, and Jane and Tim Hemenway.

Our budget included \$573.92 for supplies from Big L and \$46.11 for wood chips from Horrocks Garden Center. The remaining, \$179.97, is earmarked for the purchase of supplies to build a table in the outdoor classroom or to buy a classroom set of tree identification books. Additional donations include: Cary Linton's handmade wooden sign that marks the entrance, Lynn Wickerham's Michigan shaped birdhouse and wooden flower, and a four shelf cupboard of supplies for teachers to use (30 compasses, 30 binoculars, 30 backpacks, and a track identification kit). This is stored in CMUE's copy room.

The classroom has been used for a variety of lessons already like guitar sing-alongs, buddy reading, science investigations, reading, drawing, and even the release of Monarch Butterflies. Teachers can sign out the day and time that they'd like to reserve the classroom in the staff lounge, and they can also write suggestions or comments on a plus/delta chart located there as well.
